Burger leaves Canada to chair Sony in U.K.

Paul Burger will be leaving his position as president of Sony Music Canada to become chairman and chief executive officer of Sony Music Entertainment U.K.

Burger, 37, will have full responsibility for the day-to-day operations of the company in the United Kingdom.

Mel Ilberman, president of Sony Music International, was enthusiastic in announcing Burger's new appointment. "It is a tribute to what Paul has achieved at Sony Music Canada, as well as indicative of the strength and depth of executive talent throughout Sony Music around the world, that he is ready to take on what is an immensely important job for the company," he said in a statement.

"I have every confidence that the strong performance of our Canadian company, led by the solid management team in place and highlighted by the current global success of our Canadian roster, will ensure a smooth transition."

Burger was appointed president of Sony Music Canada (formerly CBS Records) in August 1989. Since then, Sony has become the number two company in the country with a 16 per cent market share.

Burger has also tried to raise the profile of Canadian artists both within Canada and abroad through his work with a number of organizations. This year he has been serving

Sony and Warner sign mechanical licensing deal

Sony and Warner have signed the new mechanical licensing agreement previously signed by the four other major multinational record companies, CRIA and CMRRA.

The two companies had been holding out until a separate deal was finalized between CMRRA (Canadian Musical Reproduction Rights Agency) and the Columbia House Record Club, which is jointly owned by Sony and Warner. This week an agreement was signed between Columbia House and CMRRA, prompting Sony and Warner to sign the industry licensing agreement.

After signing the deal, Sony became the

Columbia House signs new deal with CMRRA

The Columbia House Record Club has joined the six major record companies by signing a new licensing agreement.

Columbia House will pay a rate three-quarters of the industry rate because it insists that it couldn't affordably do business if it had to pay the full rate. The new rate is 4.6875 cents for songs under five minutes. One-fifth of that rate will be added for each additional minute or partial minute above five minutes.

And, for the first time, a music publisher will be entitled to instruct the Canadian Musical Reproduction Rights Agency (CMRRA) to not accept the three-quarter rate for any individual song or any catalog which it represents. Columbia House would then have the option of paying the full industry rate or dropping the publisher's material from its catalog, which could mean a major loss of revenue for the publisher.

"This agreement gives publishers the same marketplace rights that record labels have," says CMRRA president, David Basskin. "If they don't want to do business with a record club, they're not obliged."

Another new wrinkle in the agreement will see Columbia House continually providing CMRRA with detailed notifications of the songs they're using. Basskin says CMRRA would then respond with detailed confirmations of rights ownership and rates.

"Up until now, publishers have not had a reliable way of finding out from us which of their songs were being used by the record club. Now there will be an information flow that will be of great value in making sure that the right people are being paid."

Columbia House general manager Harjinder Atwal was unavailable for comment, but a spokesperson says he was "very pleased" with the agreement.

The new mechanical rate, which is retroactive to Jan. 1 of last year, will increase to 6.25 cents from 5.9 cents for songs under five minutes. One-fifth of that rate will be added for each additional minute or partial minute above five minutes.

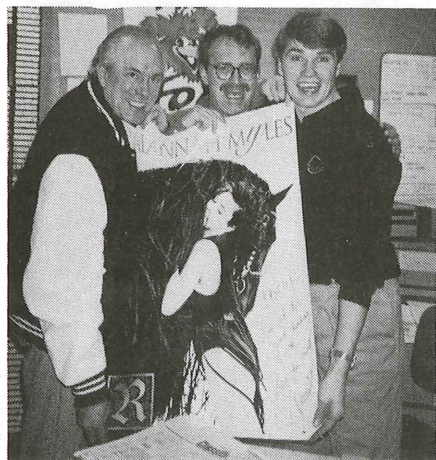
CMRRA will now submit the agreement to all the smaller independent record companies. The agency will also provide copies of the agreement along with explanatory materials to all its members, and will hold seminars in Toronto, New York City, Los Angeles and Nashville to further explain the deal and answer members' questions.

"I think it's a fair deal for both sides," says CMRRA president, David Basskin.

Brian Robertson, president of CRIA (Canadian Recording Industry Association), also thought the terms of the deal were fair. He added that it was a relief to finally have a signed agreement after two-and-a-half years of negotiations.

"One would hope there would be a better way of negotiating these agreements, but it's the first time that there's really been any fine print in this agreement. The last go-around was just basically a letter of agreement. There has never been a detailed clause-by-clause agreement. That's what has taken the time. It wasn't really the money, it was the terminology and the fine print.

"I think it will be the basis for the industry agreement for quite a few years to come, so I think we've probably made an investment for the future."

Federal Court of Appeal renders its two decisions

SOCAN is urging the House of Commons to move swiftly to enact Bill C-88 to amend the Copyright Act after the results of two Jan. 5 decisions by the Federal Court of Appeal.

The appeal court rendered decisions affecting the ability of SOCAN (Society of Composers, Authors and Music Publishers of Canada) to have two of its proposed tariffs considered by the Copyright Board (a quasi-judicial tribunal set up by the federal government to consider and approve SOCAN tariff proposals). The tariffs, applicable to the CTV Television Network and to cable television systems, were filed in 1989 applicable to 1990 and subsequent years.

The appeal court upheld a 1990 Federal Court order prohibiting the Copyright Board from considering a proposed SOCAN tariff for the CTV Television Network. That tariff would cover the music contained in programming originating from commercial networks, including CTV, and broadcast by private stations affiliated with that network. In the case of CTV affiliates, much of the advertising revenue from network programming is retained by the CTV network, and only a small amount is passed on to the affiliates in accordance with a formula contained in the affiliation agreement. Thus, composers, lyricists, songwriters and their

publishers aren't being compensated on the entire amount of revenue generated by television programs that contain their musical works.

In its decision, the appeal court applied a 1968 Supreme Court of Canada decision which held that a musical work, as defined in the Copyright Act, protected essentially only the communication (faxing or showing pictures) of sheet music (music that is written

Cancon prevalent at this year's Grammy Awards

K.D. Lang and Celine Dion lead a large group of Canadians who have been nominated for this year's Grammy Awards.

Lang's fourth Sire album, *Ingénue*, has been nominated as Album Of The Year and Best Engineered Album (for engineers Greg Penny and Marc Ramaer), while her Constant Craving single earned nominations for Record Of The Year, Song Of The Year (for songwriters Lang and Ben Mink) and Female Pop Vocal.

Dion also received nominations for best Pop Vocal Female, Record and Song Of The Year for Beauty and the Beast, her duet with Peabo Bryson. Dion and Bryson were also nominated in the Pop Duo or Group category. Beauty and the Beast received a nomination for Album Of The Year.

Rob McConnell is next in line with nominations for two jazz awards.

Tom Cochrane and Bryan Adams will renew their Juno rivalry as both have been nominated in the Male Rock Vocal category.

Alannah Myles is up for a Female Rock Vocal award.

And Daniel Lanois shares a nomination with Brian Eno for their production on U2's Achtung Baby album.

The Grammys will be awarded Feb. 24 at the Shrine Auditorium in Los Angeles.

FACTOR committed for New Talent Demos

Funding for the Foundation to Assist Canadian Talent On Records (FACTOR) New Talent Demo Award Program has been fully committed for the fiscal year ending March 31.

As a result, the Feb. 26 deadline for submitting applications has been cancelled. Any applications received at the Nov. 30, 1992 deadline that are recommended for support through the evaluation system will be considered for funding.

The New Talent Demo Award Program provides funding to new artists toward the production of a high-quality demo tape to be used to try and secure a recording contract. FACTOR defines "new" talent as an artist or group which has commercially released fewer than 10 songs.

FACTOR's application forms and program guidelines are currently under revision. Information regarding program changes and new application forms for all programs should be available in early February.

or graphically reproduced). This part of the Copyright Act has remained unchanged since enactment in 1924.

Regarding the Canadian Cable Television Association (CCTA), the appeal court upheld a 1991 Federal Court Trial decision which refused to grant a prohibition order to prevent the Copyright Board from considering a proposed SOCAN tariff applicable to cable systems for their delivery of non-broadcast services which include musical programming. The decision clears the way for SOCAN to proceed to have the Copyright Board consider its proposed cable systems tariff. But if the decision is appealed, which is almost sure to happen, the Copyright Board will be unable to consider the proposed tariff until the Supreme Court of Canada makes a final determination.

In speaking for the Federal Court of Appeal, Mr. Justice Létourneau said the court was "not insensitive nor unsympathetic to (SOCAN's) plight," but that it required action by Parliament to change the law.

Bill C-88 has been approved by a parliamentary committee, but has yet to receive its third and final reading in the House of Commons.

Maureen Jack resigns as director of PMIA

The board of directors of the Pacific Music Industry Association (PMIA) has accepted the resignation of director Maureen Jack.

There were apparently concerns that Jack's close association with PMIA and Music West, of which she was a producer, "might inhibit the unfettered growth of either organization."

The PMIA heaped much praise on Jack "for her professional commitment to the music industry in Vancouver."

Barbara Newton Vedan, senior analyst of planning and economic analysis with Western Economic Diversification Canada, has worked with Music West and Pacific Music from the beginning. She acknowledged Jack's decision, and congratulated the PMIA on "the breadth and depth of industry experience represented on the current board, and the calibre of those people, as well as an active and dynamic membership."

Vedan says, "We see Music West as a vehicle for implementing an export strategy for the Pacific music industry."

Say goodbye Paul . . . ! In the almost 29 years of publishing RPM, I've seen a number of people take over the helm of CBS/Columbia/Sony, the last being Paul Burger. The news that he was leaving to take over Sony U.K. sent shock waves through the industry. Although I had been hinting, tongue-in-cheek, for several weeks that he would be moving on, I was even shook by the announcement. Over the years, I've been openly critical of "foreigners" heading up Canadian operations, but I quickly gained a great deal of respect and admiration for both Paul and his wife Ossi, and was even welcomed into the privacy of their home for dinner. In the first couple of months of his residency, he acquired an almost voracious appetite for things Canadian. It was Paul Burger who directed that the walls of the recently renovated head office display Canadian art. It was Paul Burger who laid the framework for the Canadian Music Coalition, which will shortly become a priority happening with a major television network. Although he

didn't sign Celine Dion, she became his cause célèbre. And on the eve of his taking over Sony U.K., he received the gratifying news that she had been nominated in several Grammy categories. Paul Burger is moving on and up . . . and I don't even want to speculate on what his next move will be. I'm sure, however, that his Canadian experience will retain its value to him for some time to come. He's now a major player in a major MAJOR market and that will be good for us and could be very good for Canada. (EC: Give our regards to Barclay Square and David Munns . . . !)

How about those Canadians . . . ? Murray McLauchlan gets a Canada Medal. Bruce Cockburn is going to the American president's inaugural. Gordon Lightfoot returns to Massey Hall for his 24th year. And how about all those Cancon Grammy nominations: Alannah Myles, K.D. Lang, Celine Dion, Bryan Adams, Tom Cochrane, Daniel Lanois, and Rob McConnell and the Boss Brass . . . and I'm going to MIDEM! (EC: So what . . . I mean, who cares about you going to MIDEM . . . !)

Food for thought . . . ! It doesn't seem possible that in a country like Canada we have people who are actually going without food. I wonder how many successful recording artists and musicians remember the bad times, when they didn't know where their next can of soup was coming from? Wouldn't it be a wonderful gesture if recording artists and musicians would use their influence and ask concert or club-goers to bring along non-perishable goods that could be turned over to food banks? Radio stations have been running various programs to help the food banks for years. They could use a little help, and why not from the people they are helping. Maybe a few radio spots. I wouldn't take long! (EC: And it would make them feel warm and fuzzy all over . . . !)

A Cancon variety show . . . ! Watch for a major television network to introduce a weekly variety show to promote Canadian acts. I hope that when it happens the architects of the project don't go unnoticed. (EC: Don't hold your breath . . . !)

A night out with Loreena . . . ! Last week I was among the invited press and friends only gang for a performance by Loreena McKennitt. I can tell you, it wasn't trock and roll, but it was a thoroughly enjoyable evening. And, who's been hiding that DuMaurier Theatre? What a great, intimate setting. Even though the place carries the name of a cigarette, there's no smoking allowed. During intermission, nearly half of the 410 people in the audience had to go outside for a puff in the bum-freezing weather. Elizabethan-type music -- with its harps, lutes, tin whistles and thud drums -- had never really appealed to me. Even the happy songs are sad. But an evening of Loreena McKennitt's warm vocals made the harping, luting, whistles and thud drumming a memorable experience, and besides, 200,000 record buyers can't be wrong (The Visit will soon be certified double platinum). Unfortunately, the audience didn't pay to get in . . . you know, the casual, take it for granted crowd. Although they were with her, they were slow to react, which made her a bit

nervous. When the audience's energy reflects the energy from the stage . . . you've got a show. (EC: You mean it wasn't a live audience?)

Our industry shame . . . ! It was brought to my attention recently that a number of artists were complaining they had never received their Juno Awards back in the '60s. The truth of the matter is that, back then, the Juno Awards were considered a joke by many in the industry. There was little support for anything that had to do with Canadian artists. From 1964, when the magazine poll began, until 1975, the awards were financed by myself and RPM, which I owned solely then and still do. The first physical Juno award was presented in 1970 at the St. Lawrence Hall. Prior to July 1970, the awards were known as the RPM Annual Gold Leaf Awards. In 1970 they were nicknamed the Juno Awards, which is the name they are known by now. What a shame it is that an industry with the excesses that exist today can't start a fund to make Junos available to those pioneers of our industry who didn't get awards from 1964 to 1969. What a nice gesture it would be to show these people that the industry cares. (EC: We've come a long way since those old days of token Canadian content . . . !)

CFRB's annual gumball auction raises \$102,000

CFRB's two-foot-high gumball machine, worth fifty dollars, raised more than 2,000 times that amount for Toronto's Hospital For Sick Children at its annual on-air auction.

This year's auction, hosted by Joe Cannon and Bill Stephenson, raised \$102,000 for the hospital.

Since 1982, the annual 25-minute Gumball Machine Auction has accepted bids from Bay Street stockbrokers and been raising funds for the hospital. The highest bidder each year has the honour of displaying the gumball machine in their lobby for the entire year.

Brenda Burns, director of community relations for the station, explains that all bidders are required to donate their final bid, thus pushing this year's unprecedented grand total to \$102,000. With this year's donation, more than \$700,000 has been raised over the 11 years the campaign has ran.

The winning brokerage firm this year was Scotia McLeod, represented by David Keith, vice-president of institutional bond

sales, with the top bid of \$38,500.

The runner-up was Nesbitt Thomson, represented by Noel White, vice-president of institutional bond sales. White has been instrumental in organizing the annual auction and was the highest bidder for the past several years. Their bid this year was \$38,000.

Taking third place was a syndicate comprised of Shorcan International Brokers Limited (James Magee, president), Goldman Sachs (David Gluskin, vice-president), Levesque Beaubien Geoffrion Inc. (Norma

CHUM makes bid to buy Kitchener stations

Allan Waters, president of CHUM Limited, and Zoltan D. Simo, president and CEO of Electrohome Limited, have jointly announced an agreement whereby Electrohome's Kitchener radio stations, CKKW and CFCA-FM, would be sold to CHUM Limited.

The sale is subject to CRTC approval and applications for the transfer have now been filed with the Commission.

Electrohome apparently wants to focus on the television broadcast side of the business which W.D. McGregor, vice-president of Electrohome, admits the sale of the two stations "will position the company to do." He also expressed his pleasure that the transaction "is with such a strong radio operator." CHUM Limited is one of Canada's largest radio broadcasters with 20 stations across Canada.

Fred Sherratt, vice-president of CHUM Limited, stressed that the addition of the Kitchener stations "is a natural extension of CHUM's radio operations in Canada," pointing out that both stations "have a strong record of service to the communities they serve and have gained and maintained leading positions in their target audiences." He declared that CHUM "is committed to their continued long-term development."

CFCA-FM 105.3 maintains an adult, easy listening format, while CKKW AM 109 targets a younger audience with CHR programming.

New Top Secret album now out from Prophecy

Rap/hip hop group Top Secret, led by rapper/writer/producer RP Rap (Ryan Patrick Lord), has a new cassette album entitled *It Ain't Over*.

The album is released on Rap's own Prophecy Records label. The first single is entitled *Listen To Yourself*, which is also included on the CD soundtrack for the soon-to-be-released film, *Bust A Move*. Four videos, two of which were directed by Rap, have already been completed for the album.

One thousand cassettes have been issued initially and it's hoped that *It Ain't Over* will be available on CD at the end of February.

Top Secret has previously released a single and video called *Don't Make Me Mad Son*. RP has also done musical consultancy work with CTV's *ENG* and YTV's *Maniac Mansion*, for which he received a Cable ACE award nomination.

Five years, \$1.3 million for Standard's Cancon airing

Gary Slight, president and CEO of Standard Radio Inc., has announced a bold and unique plan to promote Canadian content albums on all Standard Radio stations.

Beginning Feb. 1 and running continuously for five years, the Standard stations will air 10 free 30-second commercials each week promoting a Canadian album.

Included in the campaign are Toronto's Mix 99.9, CHTZ St. Catharines, Ottawa's 54 Rock, Montreal's Mix 96, Edmonton's Oldies 1260 and CFBR, and Calgary's AM106 and CJAY-FM. The weekly circulation of the stations is estimated at close to two million and Slight estimates the value of the campaign to be in the neighbourhood of \$1.3 million.

Mix 99.9 music director Wayne Webster will co-ordinate the project in conjunction with all Standard Radio's music directors. The commercials will be produced by Standard at no cost to the artist or release label. The only criterion is that the album is a current Canadian release. The titles will rotate every week.

Loreena McKennitt does well in international polls

Loreena McKennitt's Warner Music Canada album, *The Visit*, without the benefit of much radio airplay since its release in the fall of 1991, is now nudging the double platinum (200,000 units) mark in Canada.

McKennitt is also capturing the imagination of both critics and fans on the international scene. McKennitt toured extensively throughout the U.S. in support of *The Visit* and critics from the dailies and trade press were quick to respond positively, resulting in steady gains at retail.

The January issue of England's popular *Q* Magazine also named *The Visit* one of the Top 50 albums of 1992.

McKennitt has begun work on her fifth album, which is tentatively scheduled for a fall release.

The battle for second. Whitney Houston continues to dominate both the Hit Tracks and Albums charts. However, six of the next seven songs on the Hit Tracks chart are moving up. Celine Dion's *Love Can Move Mountains* edges into the No. 2 spot, while Go West's *Faithful* hits No. 3. That matches the peak position of the band's previous big hit, *King Of Wishful Thinking*.

Not missing a beat. The solo career of Annie Lennox has been sailing right along. *Little Bird* bullets to No. 18 and appears headed for the Top 10. If it does go that high, it would be the third release from Diva to do so (*Why* reached No. 7 and *Walking On Broken Glass* hit No. 1). The title track to *Bohemia* had the highest entry when it was released back in October. Compare that to her first album, *Oceanview Motel*, when no songs accomplished that feat.

Sass tops out west. *Goin' Back Again* holds its position at No. 14. The Sass Jordan song has seen strong support out west, especially at CKSA Lloydminster. Music Director Jeff Hollick reports the song at No. 1 for the second week in a row.

Halo fever! I can just picture it now. An announcer is ready for the first shift at their new radio station. He/she grabs the music playlist and figures someone is joking around. Their show starts with The Heights' *How Do You Talk To An Angel* and continues with The Jeff Healey Band's *Heart Of An Angel*, Blue Rodeo's *Angels* and Jon Secada's *Angel*. Closed captioned videos introduced by Capitol

Capitol-EMI and Virgin Music are the first record labels in Canada to introduce closed captioning for the hearing impaired on all domestic music videos.

Closed captioning is a type of lyric scroll that appears at the bottom of the television screen, enabling viewers to read the lyrics while they watch the video. All TV sets manufactured after July 1993 will include a decoder as standard equipment. This means that anyone, not just the hearing impaired, will have access to closed captioned broadcasts.

*COVER STORY - by Steve Mclean***Does Ontario need a music industry association?**

Regional music industry associations have been sprouting up across Canada in the last few years. The Pacific Music Industry Association, Alberta Recording Industry Association, Saskatchewan Recording Industry Association, Manitoba Audio Recording Industry Association, Music Industry Association Of Nova Scotia, and the Newfoundland and Labrador Music Association are all active. Now there is talk of forming an Ontario music industry association. Many are in support of the idea, saying that the organization could act as a source of information, support and lobbying power for musicians who may not have easy access to the services offered in Toronto, generally considered the capital of the Canadian music industry. Others in the industry feel that existing national organizations are sufficient, saying that regional associations are divisive and could fragment the Canadian industry. And still others believe that regional associations can serve a useful purpose, though they still harbour some reservations.

RPM talked to seven people involved in the Ontario music industry and recorded their comments on the pros and cons of forming an Ontario music industry association.

Graeme Boyce, Raw Energy Records

Forming an Ontario recording industry association is bad for Canada's music identity. At a time when the Americans are finally looking up to Canada, the regions are all fighting among themselves. That's ludicrous. I can understand friendly competition, but there's no friendly competition between the provinces. It's very political. This regionalism has got to be nipped in the bud.

I think there are national organizations that are serving the music industry sufficiently. I don't think that these regional organizations are doing any good. I don't think that they're answering the questions that need to be answered. It's just going to water down the industry. Individual cities will start forming their own associations.

I was always taught that music has no boundaries. It's an international language. I don't think that an Ontario music industry association is going to ultimately provide Canada or the world with better musicians.

Floyd Chan, Yonder Records and Audio Plus Management

It is something that, if it's worthwhile, I wouldn't mind doing. I just haven't heard enough arguments for or against it to make a decision on whether or not to go ahead with it. It's still something that's very much in the research stages.

On an international and federal level, there is no representation for Ontario. It's just assumed that the national organizations such as CIRPA and CRIA would represent Ontario.

Artists who live in Thunder Bay or London should be as equally represented as those in Toronto. I believe that, on an international level, we're going to have to represent what's good in Canada rather than

simply putting someone on a bill because they live in Thunder Bay or London. But at least if there is a good band in Thunder Bay or London, they should be given the opportunity to perform.

A lot of the provincial organizations came about because they felt isolated from the major markets. Therefore, to feel that there was enough representation and to pull it together for people in those areas, they formed these little cliques that over a period of time turned into organizations. So, therefore, the mandates for each organization are different in each province.

Brian Chater, CIRPA president

We've got enough organizations as it is. God knows there are too many of them to start with. Why start another one that will do basically the same thing? You'll just trip over everybody else and it will create work that doesn't need to be done. God knows there's enough work to do without that. So, from my personal view, I can't see it being particularly useful.

You'll get an argument from people outside Ontario that we represent Ontario anyways because most of the business is here. That's why they have to have provincial associations whereas we theoretically wouldn't because I talk to people from Ontario every day and deal with them all the time on the same issues that anybody else would for Ontario. Obviously, from our point of view, we push our Ontario members' interests with Ontario. We're the base of the industry in Toronto anyways and it's in Ontario's interest to work with us and produce programs.

Why keep forming new things when you've already got something in place? If you don't think it's doing the job, come and complain.

John Harris, Harris Institute For The Arts

I think it's an excellent idea. We have, over the last 15 or 20 years, seen that industry organizations have played a major role in advancing the overall infrastructure of the industry. There's never been an Ontario organization and it's probably time for this province to organize. I think it can be valuable from two perspectives. One is the transfer of information to people starting out who need to find out where to go and how things work, and also from a lobby perspective.

CIRPA is doing a lot, but a lot of their initiatives are on a national scale in terms of Canadian content, et cetera. I think they should be a national organization although, I suppose, CIRPA could play a role in this because a lot of the membership of CIRPA is in Ontario. I think CIRPA's doing a great job at what they're doing. But they don't have a specific focus on the industry specifically in Ontario, and I think it would be advantageous to have an organization doing that.

Because I'm basically in the education business, I have witnessed that the more people know, the better they are equipped to advance what they're trying to do. And any mechanism

to disperse information is going to be helpful.

Provinces out west or out east, because they're further away from the major centre of information, which is Toronto, have a desperate need for their provincial organizations to disseminate information to people who live in those territories. It's the same thing in Ontario. Even though there's a lot happening in Toronto, if you're in Thunder Bay or Sudbury or some of the areas that are a fair distance from Toronto, you could be in Winnipeg.

I think, in all probability, the provincial organizations, for a lot of things, will work together and share information. I suppose there would be an element of competition in terms of the interface with the federal government in terms of accessing whatever, but if you look at the industry organizations that exist now, they're working more in harmony today than they ever have in the past, and I would assume that that trend would continue. For the first time in my recollection there are now various initiatives that all the industry organizations are working together on. It seems that there is a general understanding that working together is going to help everybody.

Al Mair, Attic Records president and CIRPA chairman

It's healthy that people in a particular geographic area can get together and talk to each other and learn. That can only be helpful.

My only concern about a brand new Ontario organization is how it would fund itself. In the case of the Department Of Communications in Ottawa, all the regional societies are after the DOC for funding, and there's a limited pot which could very easily be reduced next year because of the limited economy.

It's a lot better for FACTOR and the industry when it's a consensus opinion that comes through a local association (of people) who live there and work there and know what that area needs. I see that as healthy but, when you talk about an Ontario association, I just have to think about the impact of it if CIRPA lost its Ontario members who thought that they should join a local organization for five or 10 dollars. If CIRPA was weakened, all the regional associations would be weakened because none of them do lobbying of any consequence. They send the odd letter, usually in support of what CIRPA's doing. But very few, if any of them, have ever appeared at a CRTC hearing, for example.

When you get into lobbying and sophisticated information, you need professional full-time people. And none of the regional associations, as far as I know, have got any full-time staff. They're all volunteers, which means if they have time to do something they do it, and if they don't, they don't. That's why CIRPA, having a staff, as well as a larger membership representing people from coast-to-coast and a substantial board of directors, usually has the time to do everything that has to be done.

With CIRPA you're seeing 20 years of building and support for the industry. I would

hate to see it weakened by a positive action taken elsewhere, no matter how well-meaning. It might be that CIRPA could be the parent of a new Ontario division. You've got a real cross-section of the major players in the Ontario music industry who are already members of CIRPA and are usually on the board and therefore understand. There's nothing to stop any new group of people from starting an association, but they'd be starting from scratch. I don't know off-hand who, of the experienced people, would be attracted to such a group unless it was involved in some way with CIRPA directly.

I think CIRPA is the umbrella organization of all the associations, in some cases formally and in some cases informally, but any presence internationally is best done by one organization on behalf of the industry. It would be inappropriate to have 10 provincial organizations doing something at MIDEM. It would not fly financially. How confusing would it be for someone from Japan to walk past a booth that said Newfoundland? They wouldn't even know what it is and, therefore, they probably wouldn't have any interest.

Mark Smith, DMD Promotions

I think we need somebody in each province or each region to explain what's available. The more people get together and help each other, the more we're all going to get ahead.

We have to start educating Canadians more about what they are and what we have. We've got to see if we can make them more aggressive. I think some of the provincial associations are getting pretty aggressive. Right now there's some really good demo

tapes coming out of Saskatchewan and Manitoba, which have been notorious for really bad demo tapes over the past four or five years that I've been doing A&R stuff. There are actually some independent record labels starting up in Manitoba.

You don't really need to be here (Toronto), you've just got to know how to work here. And that's what we have to teach people.

CIRPA's doing a great job but they haven't got a full-time press person to contact every tiny community paper. And people out there don't really care because they don't know anybody, and they're getting a press release from Toronto about a conference.

There's no real group of people yet to put together an association. It's just that several of us bring it up every chance we get. Hopefully somebody will get excited about it.

I would really like to keep it out of record company hands. It's got to be run by the artists.

Heather Sym, FACTOR executive director

It won't be watering down or duplicating what FACTOR's doing. It's going to be picking up on and addressing issues that we're not able to. It's going to be providing a stronger support system because I know there's going to be marketing and promotion and some very basic demo support and funds for domestic touring. These are the kinds of things that I understand are going to be addressed through the provincial programs and they're not things that FACTOR is in a position to respond to. I think they'll complement each other.

December certifications up over previous year

The Canadian Recording Industry Association (CRIA) registered 44 certifications for December 1992, up from the 37 registered for December 1991.

Some observers view this modest increase as a signal of economic recovery in the record industry. Major retail chains, for the most part, were very pleased with December sales when they finally kicked in. Manufacturers are also pleased with the sell-through activity they experienced in the first week of the new year.

Leading the metal parade for December was Metallica's self-titled album, certified by Warner Music as seven times platinum.

Fur trapping controversy spurred by Ladies song

Barenaked Ladies have patched up their differences with Toronto's City Hall, but now Metis in Yellowknife, N.W.T. have a bone to pick with the band.

Metis plan to boycott and picket the Ladies' already sold-out Feb. 28 concert in Yellowknife because they object to the lines "If I had \$1,000,000, I would buy you a fur coat, but not a real fur coat that's cruel," in one of the group's songs. Many northern Metis earn a living from fur trapping and feel that the lines paint them in an unfair light.

The band, which is currently on tour in the United Kingdom, released a statement saying, "We believe that everybody should be able to make their own ethical decision on how they feel about fur. Although the line in question was originally intended as a satire of knee-jerk reactions to such broad debates, we

are aware of the complexities of the fur issue.

"We understand that fur has played a major role in our country's heritage and that it is still a vital facet of many people's livelihoods and traditions. All members of our band do eat meat and wear leather, however our personal choice is to draw the line at fur, especially as a statement of wealth."

Moxy Früvous to play Ottawa's CentrepoinTE

Toronto's Moxy Früvous is set for a Feb. 5 date at the CentrepoinTE Theatre in Ottawa.

The band is named after a 15th century order of monks in eastern Europe who baked the magical Früvous bread to ward off evil doers.

The band gained much industry attention with the release of their independently-produced six-song "teaser," which has sold more than 25,000 copies to date. They have appeared on The Journal, YTV and The New Music. Their first video, King of Spain, is now in rotation on MuchMusic.

Acid Test showcase and edit Dance video

Acid Test, the innovative Toronto dance group that signed with Sire Records in December, recently played a showcase at the legendary CBGBs club in New York City for American booking agents and Sire representatives from New York and Los Angeles.

The group is now talking to producers and plans to go into the studio in the next few weeks to start recording their Sire/Warner debut. The album will be recorded in Canada, as was the group's current independent release, Trip on This.

The video for Acid Test's current single, Dance, directed by acclaimed Highway 61 and Roadkill director Bruce McDonald, was deemed too racy for MuchMusic. Although there are no explicitly graphic shots in the video, Much representatives thought that the sexual inferences in some scenes were unsuitable for daytime play.

McDonald has grudgingly agreed to edit the video to make it conform to MuchMusic's daytime standards.

Cockburn firmed to play U.S. inaugural concert

Add Bruce Cockburn's name to the growing list of Canadians scheduled to perform at the festivities commemorating Bill Clinton's inauguration as president of the United States.

On Jan. 20, Cockburn will perform at the Tennessee Inaugural Ball with Lou Reed and former tour mates Bob Weir and Rob Wasserman. U.S. vice-president-elect Al Gore hails from Tennessee. An audience of 5,000 is expected for the show at the Washington Hilton.

Cockburn is currently working on his new album for True North Records. The album, due out this summer, will be his 21st.

SOCAN sets deadline for festival grant applications

The SOCAN Foundation, formerly Music Promotion Foundation, has set this year's deadline for grant applications from Canadian folk festivals at March 31.

Funding requests to SOCAN were previously reviewed by the SOCAN Communications Committee and Board of Directors. The Foundation now handles all applications.

SOCAN grants have been approved for a number of festivals across Canada in recent years. The grants are designed to promote and encourage the performance of Canadian music.

SOCAN is the national performing right society that licenses the public and broadcast performance of music on behalf of composers, lyricists, songwriters and music publishers.

Harbourfront Centre announces summer lineup

Toronto's Harbourfront Centre has announced the basic framework for its summer music season at Molson Place and various stages around York Quay Centre.

The Earth Spirit Festival, produced in partnership with the Earth Spirit Festival Association, will return from July 9-11 with a collaboration between native Canadians and Chinese Canadians and will include workshops, film, dance and visual arts.

The International Hispanic Fiesta, produced in conjunction with Las Flores Foundation, will expose audiences to Hispanic music and dance from Canada and around the world from Sept. 3-6.

Molson Special Dry will sponsor 10 theme weekends featuring intercultural music experiences from Latin America, Asia and Africa. Africabeat (July 30-August 2) will explore hybrid styles from Africa and the Caribbean. Musicwomen (Aug. 20-22) will celebrate women of all cultures working in the music industry today. And the popular Big Squeeze Accordion Festival (Aug. 27-29) will present the many cultural and historical incarnations of the accordion.

The biggest disappointment of the season will be the absence of the World Of Music, Arts and Dance (WOMAD) weekend festival.

"Honest Ed" Mirvish receives Hostelry award

Popular Canadian entrepreneur Ed Mirvish, affectionately known as "Honest Ed," was the recipient of yet another award, this time from the Ontario Hostelry Institute.

OHI chairman Charles Grieco presented Mirvish with the Chairman's Award at the OHI Awards Dinner at the Four Seasons Hotel, Yorkville in Toronto on Jan. 14.

Besides creating Honest Ed's, the landmark discount retail store, Mirvish was the driving force behind the Royal Alexandra Theatre as well as a new theatre being constructed to accommodate Miss Saigon, which is scheduled to open in May.

Mirvish also owns six restaurants in the shadow of the Royal Alexandra, an area that also houses Ed's Theatre Museum. Also carrying the famous name is Mirvish Village, a group of restaurants and boutiques that border his retail store.

Year-end certifications rise in 1992 over 1991

The Canadian Recording Industry Association (CRIA) recorded 16 more certifications last year than in 1991.

The total number of certifications was 418, compared to 402 in 1991. The number of Cancon certifications rose to 101 from 74.

CRIA president Brian Robertson was heartened by the year-end results, saying, "The CRIA certifications should not be used as a barometer to measure the health of the Canadian recording industry, but the increased level of certifications is encouraging, particularly the Canadian content recordings which show an overall increase of 36 per cent over 1991. These figures do not include the million-plus selling album Waking Up The Neighbours by Bryan Adams, or Celine Dion's two quadruple platinum albums, Unison and Celine Dion, which did not qualify as Canadian content under the CRTC regulations."

Music video certifications for 1992 more than tripled the total for the previous year. Thirty-eight videos were certified last year compared to 12 in 1991.

David Foster commits to produce Rick Jones

Internationally-acclaimed producer David Foster (Celine Dion, Barbra Streisand, Michael Bolton) will produce two sides for Rick Jones.

The 31-year-old singer/songwriter from Ontario's Haliburton region, first met Foster a few years ago in Nashville, where he was making the rounds of record companies with his manager, B.J. Cook. Foster was impressed with his first meeting and subsequent tapes sent to him by Cook.

Foster explains, "Country music is hot and, with 1993 here, I'm moving in its direction."

Fortunately for Jones, he was a priority with Foster, who is already touting the industry to secure a record deal for him. Jones performed at Santa Fe's (Toronto) New Country for three days (Jan. 14-16), which drew an impressive turnout of industry presidents and A&R managers from both the major and independent labels.

Jones, who keeps the wolf from the door with a day job as a truck driver, has been playing the bar and club circuit with his band Silverthorn for several years. He worked the Alberta circuit for four years, returning to Toronto where he gained recognition and respect in the music community with his writing talent. He made further inroads into the performance side of the business as guitarist for Graceland's first houseband when the Scarborough (Toronto) country showplace opened a few years ago.

Just prior to the Foster connection, Jones was considering heading back to Alberta with two of his band members: guitarist Dougie Devereaux and D.W. (Doug) Johnston on pedal steel. In view of the Foster interest, he is now in the process of beefing up his band with a strong rhythm section. He will also continue to use the unique fiddle talent of June Eikhard, Shirley's mother, on occasion.

Lennie Gallant video sets pace for new year

1992 was "a watershed year" for Lennie Gallant says his manager, Campbell Webster.

The exceptionally talented Cape Bretoner caught programmers off guard with two of his releases, *The Cry For Love* and *Man Of Steel*, both of which became Top 40 hits. Both tracks were taken from his *Believing In Better* album.

Gallant toured Canada three times last year, beginning on a cross-Canada tour opening for the *Crash Test Dummies*. Gallant and his band were called back for encores at every show during the two-month tour, which is rare for an opening act. The press also gave the Gallant group equal coverage, which is also rare for an opening act.

The young songwriter is banking on this national recognition to continue into the new year. He was one of the first Canadian acts on the market this year with a video, a move that has already garnered him medium and heavy rotation on major video shows. The new video, *Is It Love I Feel?* (Or *Courage I Lack*), was produced by Montreal's Cinoque Film, which regularly wins international and Canadian music video awards. Cinoque has also produced a video for Celine Dion. The track for the video is included on *RDR Countrypak 15*, now shipped to radio.

A major coup for Gallant last year was his signing with U.S. agent, Fleming Tamulevich. His roster of artists include

Bourne and MacLeod, Stephen Fearing, Connie Caldor, Garnet Rogers, the Royal Canadian Air Farce and Second City. Tamulevich will be booking Gallant's spring '93 tour throughout Canada and the U.S., although he will continue to work with Brookes Diamond Productions in the area of distribution through Atlantica Music.

Gallant is also scheduled for two new recording projects this year. The first, a CD single, is a tribute to Gordon Lightfoot with Gallant performing one of Lightfoot's songs. The second is a two-track cassette sponsored by Oxfam Canada. The cassette will be sold throughout Canada as a fundraiser and will feature Gallant's penning of *Land Of The Maya*. Gallant wrote the song about the struggles of the native people of Guatemala after his human rights tour of the country.

Beginning Feb. 5, Toronto's five Festival Movie Theatres (Bloor, Fox, Paradise, Revue and Kingsway Cinema) will run Gallant's video, *Man of Steel*, for a two month period. The video, which won the 1992 East Coast Music Association Video of the Year Award and was nominated for MuchMusic's Canadian Music Video of the year Award in the VideoFact category, will be shown at 7 p.m. and 9 p.m., just prior to the main feature.

Webster estimates that roughly 27,000 Toronto moviegoers will see the video over its 140 screenings.

Tony White, one of the big country voices of the '60s and '70s (B Myself, Big Window, Travelling Road Show Band, Good Old Country Music, I Don't Want To Cheat On You), has returned to country music with a new release.

White is as aggressive in his promotional approach now as he was when he was releasing on the Columbia and RCA labels. His first

He now performs regularly as a trio with drummer Doug Strachan and bassman Bruce Baycroft.

One of White's big breaks was when his trio was booked for Music '91 as one of the opening acts for John Denver. The energy he felt from the more than 5,000 country fans at the Fort St. John show convinced him to return to the business.

White teamed with Barry Allen, a nationally-known rocker from the '60s and now a successful producer and associate with Edmonton's Homestead Recorders, to co-produce his new album. White wrote most of the material, which he says was written about what he saw and felt during the past six years. White admits to writing from the heart, and his polished vocal stylings add to the sometimes emotional qualities of the songs.

The RPM reviewer, however, found that White's sound "is as pure and edged with that same vocal warmth and emotion that made him so popular back then." Two of the songs on the album, *Oh Linda* (This Song Is Just For You) and *Let My Feelings Show*, were co-written with Karl Eriksen.
